With a vision to **build stronger nonprofits to build a stronger community**, our mission is to communicate, convene, and create resources that build the capacity of nonprofit agencies and the effectiveness of those who work and volunteer in them.

One of the joys of preparing an annual report is that it allows us to reflect and be thankful for the opportunity we had to serve the Miami Valley nonprofit community. 2021 afforded us the opportunity to continue serving area nonprofits as they navigate the longer-term effects of the COVID-19 pandemic. Some of the highlights of our work in 2021 were:

- Continued offering affordable programming in a virtual format, increasing our reach to new organizations by 18%, and expanding our geographic footprint in the nonprofits we serve.
- Fully launched our *Core Excellence* workshop series covering the critical areas of professional nonprofit management, serving 87 staff and board members that represented 65 unique nonprofits.
- Designed and delivered our new *Nonprofit Refresh* consulting packages, serving 5 local agencies, providing support in fundraising, teambuilding, grant writing, special event planning, human resource management, and nonprofit policy & procedure development.
- Served 550 nonprofit professionals in 2021 in our virtual training programs.
- Celebrated that nearly 3,000 nonprofit professionals representing over 500 agencies have participated in networking, training and leadership development programs since our inception in 2015.
