## With a vision for a *vibrant community of sustainable nonprofits*, we are pleased to share some highlights of our work in 2025:

- Celebrated 10 years of service to the community, having provided over 8,000 training experiences to over 500 area nonprofit organizations over the years.
- Delivered 27 MVNC OnSite group training programs, assisting with professional development and teambuilding efforts.
- Launched 4 new topics in our MVNC OnDemand e-learning platform to help nonprofits strengthen their board of directors, elevate their board meetings, plan for succession, and consider their next strategic planning effort.
- Launched a complimentary training session for community members considering starting a not-for-profit in the State of Ohio.
- Served 1,219 nonprofit professionals in 2025 through our in person trainings & networking events, along with our growing OnSite group training and OnDemand e-learning offerings.
- Distributed 93 grant-funded scholarships for a myriad of training programs through the generosity of local foundation partners.






**The following is an overview of MVNC's internally reviewed finances for the fiscal year ended December 31, 2025.**
